 沒有投票權、選舉權和被選舉權。

 2.經本會評審認可
 會員權利

1.發言權;

2.參加本會舉辦之年會及其他各項活動之權利;

3.其他依法應享之權利。

備註:

- 首次申請入會者或重新申請入會者須繳交入會費及常年會費。常年會費方面,在上半年加入的新會員應繳交全額常年會費,六月後加入的則可繳半額常年年費。
- 每年的續會期限為2月28日,會員若過了繳費限期仍未繳交會費,將會被中止會員資格。若過了繳費限期而欲續會者,必須再繳交入會費。



Macau Association of Speech Therapists (MAST) Types of membership, eligibility of application, rights of membership and membership fee

Type 1 Regular membership

Eligibility

1.Holder of Macao identity card (temporary or permanent),

2. bachelor or higher degree holder of speech therapy or speech language pathology, and

3.as recognized by MAST committee

Respective rights entitled to regular membership

- 1. Freedom of speech and freedom to vote during annual general meetings and in whatsapp communication group
- 2.Freedom to elect committee members and be elected in the committee; freedom to propose removal of office of certain committee members; and freedom to appeal
- 3.Participate annual general meetings and events organized by MAST
- 4. Other rights not listed thereof

Type 2 Associate membership

<u>Eligibility</u>

1.Bachelor or higher degree holder of speech therapy or speech language pathology, and 2.as recognized by MAST committee

Respective rights entitled to associate membership

- 1.Freedom of speech during annual general meetings and in whatsapp communication group
- 2.Participate annual general meetings and events organized by MAST
- 3.Associate members do not have the right to vote, elect committee members and be elected in the committee

Type 3 Student membership

<u>Eligibility</u>

- 1. Students studying speech therapy or speech language pathology, and
- 2.as recognized by MAST committee

<u>Respective rights entitled to student membership</u>

- 1.Freedom of speech during annual general meetings and in whatsapp communication group
- 2.Participate annual general meetings and events organized by MAST
- 3. Other rights not stated thereof



Macau Association of Speech Therapists (MAST) Types of membership, eligibility of application, rights of membership and membership fee

Membership Fee

| | Initial joining/re-joining fee | Annual membership fee |
|------------------|--------------------------------|-----------------------|
| Regular member | MOP100 | MOP400 |
| Associate member | MOP100 | MOP300 |
| Student member | MOP100 | MOP100 |

Remarks:

- Both new application / reapplication carry the initial joining/ re-joining fee plus annual membership fee. For annual membership fee, new members who joins in the first half of the year are required to pay full annual membership fee, while those who joins after June are required to pay half of the annual membership fee.
- Deadline for membership renewal is 28 February every year. Members who fail to pay the annual fee before the deadline of each year shall cease the membership. For those who renew the membership after the deadline of each year will be required to pay the rejoining fee in addition to the annual membership fee. *In case of discrepancies between Chinese and English version of this document, the Chinese version shall prevail in all respects and interpretations.
